NCDHD encourages district residents to continue to wear your mask in public places or where social distancing is difficult as well as practice social distancing while out in public. With recent public gatherings and school events coming up in the near future, continue to monitor for signs and symptoms for COVID-19. NCDHD has transitioned recovery reporting as of Thursday, April 8<sup>th</sup>. DHHS has indicated that positive cases greater than 21 days are considered to be recovered unless listed as a fatality. Reporting on recoveries will continue to be updated each Thursday in media releases.
