4/11/2022 NCDHD COVID-19 Updates

Public Service Announcement

Effective April 11th, 2022, NCDHD will be moving COVID media releases to an as needed basis. Updates will be published if our service area sees an uptick in case counts, concerns with variants or any changes on vaccine administration.

North Central District Health Department (NCDHD) has been made aware of 5 new COVID-19 cases in the district since last reporting period on 4/04/2022.

Vaccine Reminders:

The following groups can get 1st or 2nd boosters at this time:

- 2nd boosters are available for persons aged 50 and older
- 2nd boosters of Pfizer or Moderna are available to persons aged 18 and older that received Johnson and Johnson for their 1st and 2nd dose
- Any individual over age 12 with immunocompromising conditions is eligible for a COVID-19 booster dose 3 months after their 3rd dose and 4 months after their 4th dose.

If you have questions about your eligibility or when you should get your booster dose, please contact your medical provider or NCDHD at 402-336-2406.

NCDHD will have additional booster doses available at all clinics effective 3/30/2022. To view a schedule of clinic sites, please visit the NCDHD website and click on Vaccine Schedule.
