**NCDHD COVID-19 Updates**

Public Service Announcement

North Central District Health Department (NCDHD) has been made aware of 94 new COVID-19 cases in the district since last reporting period on 9/27/2021.

District-wide and county case count will now be reported Wednesday and Friday evening. These case-count updates will not include new recoveries and deaths; those will only be reported in the Monday press-release.

Friday, September 24<sup>th</sup>, 2021, the CDC has endorsed recommendation for a booster shot of the **Pfizer-BioNTech COVID-19 vaccine** in certain populations and recommends a booster dose for those in high risk occupational and institutional settings. The FDA authorization and CDC's guidance for use are important steps forward as we work to stay ahead of the virus and keep Americans safe. Currently, **NCDHD is waiting for official orders to start administering the booster dose**. When available, NCDHD will notify all media sources. When available, the individuals who qualify for a booster does are:

- people 65 years and older and residents in long-term care settings should receive a booster shot of Pfizer-BioNTech's COVID-19 vaccine at least 6 months after their Pfizer-BioNTech primary series,
- people aged 50–64 years with underlying medical conditions should receive a booster shot of Pfizer-BioNTech's COVID-19 vaccine at least 6 months after their Pfizer-BioNTech primary series,
- people aged 18–49 years with underlying medical conditions may receive a booster shot of Pfizer-BioNTech's COVID-19 vaccine at least 6 months after their Pfizer-BioNTech primary series, based on their individual benefits and risks, and
- people aged 18-64 years who are at increased risk for COVID-19 exposure and transmission because of occupational or institutional setting may receive a booster shot of Pfizer-BioNTech's COVID-19 vaccine at least 6 months after their Pfizer-BioNTech primary series, based on their individual benefits and risks.

Need a COVID-19 test? Cherry County Hospital is offering FREE rapid COVID-19 testing. This service will be offered Monday and Friday from 2p-3p. To register, a patient should call Cherry County Hospital 402-376-2525 or Cherry County Clinic 402-376-3770 and press pound to be connected to the registration voicemail. Cut off for registration is 12pm the day of testing.

NCDHD has the following clinic times available for walk-ins during the noted times below. If you already have a scheduled appointment time for a clinic on this list, please arrive at that scheduled time.

Please note any location updates. Also, **please bring a photocopy of your insurance card. If you do not have insurance, you are still eligible to get your COVID vaccine.** These clinics will be dispensing **Pfizer, Johnson & Johnson and/or Moderna** vaccine. Please note by the location which clinic will be offering which vaccine.
