Public Service Announcement

North Central District Health Department (NCDHD) has been made aware of 461 new COVID-19 cases in the district since last reporting period on 1/24/2022.

NCDHD is offering scheduled COVID-19 Testing through TotalWellness on Mondays, Wednesdays, and Fridays. PCR and Rapid tests are available. This testing is offered in O'Neill and is BY APPOINTMENT ONLY. NO WALK-INS ACCEPTED. This testing can be utilized by symptomatic/exposed individuals or for those in need of a COVID-19 test for travel. To register, visit https://login.registermytime.com/tw/ncdhd. Any individual who has immunocompromising conditions qualify for a 4th dose of the COVID-19 vaccine 5 months after their 3rd dose.
