# NCDHD COVID-19 Updates

## Public Service Announcement

North Central District Health Department (NCDHD) has been made aware of 75 new COVID-19 cases in the district since last reporting period on 8/23/2021.

The Pfizer COVID-19 vaccine now has full FDA Approval for use for individuals 16 years of age and older. It remains EUA-approved for those 12-15 years old & 3<sup>rd</sup> dose recipients. Regarding NCDHD COVID Vaccine clinics, we will now be **requiring insurance card information** prior to receiving a COVID-19 vaccine. A photocopy of the front and back of insurance cards is needed. **If you do not have insurance, you are still eligible to get your COVID vaccine.** Please call our office with any questions.

The CDC signed the Advisory Committee on Immunization Practices recommendation that endorsed the use of an **additional dose of COVID-19 vaccine for people with moderately to severely compromised immune systems after an initial two-dose vaccine series**. CDC's recommendation are people with a range of conditions, such as recipients of organ or stem cell transplants, people with advance or untreated HIV infection, active recipients of treatment for cancer, people who are taking some medications that weaken the immune system, and others. The additional dose of an mRNA COVID-19 vaccine should be the same vaccine as the initial series and administered at least four weeks after completing a primary mRNA COVID-19 vaccine series. CDC does **not** recommend additional doses or booster shots for any other population currently. **NCDHD is pending updated orders to begin administering this booster shot timely.** Please monitor media for the quickest update on order approvals.

If you are a non-healthcare facility interested in free, routine PCR testing for COVID-19, visit <u>www.testedandprotected.org</u> to learn more about the Expanded Testing program managed by the Midwest Coordination Center. Eligible groups include public/private schools, nursing homes, shelters, correction facilities, youth-serving organizations, childcare centers, youth summer camps, etc. If you have any questions regarding this testing opportunity, please feel free to contact our office.

Case count update as of 8/30/2021 at 3:00 PM: 4,797 Total Cases (TC), 4,544 (R), 76 Deaths (D), and 143 total cases reported in the last 14 days. NCDHD is no longer able to release county-based data in our districts due to HIPAA standards. Previously, we were granted special privileges to release the county-based information. Those special privileges expired July 31<sup>st</sup>, 2021. If interested in county-based

data, it is still available on the CDC's website at <u>https://covid.cdc.gov/covid-data-tracker/#county-view</u>. Please keep in mind that this data tracker is updated once weekly, and it does not keep count of any type of antigen or rapid test. It only has data based on PCR tests.
