NCDHD COVID-19 Updates

Public Service Announcement

North Central District Health Department (NCDHD) has been made aware of 128 new COVID-19 cases in the district since last reporting period on 8/30/2021.

District-wide case count will now also be reported Wednesday and Friday evening. These case-count updates will not include new recoveries and deaths; those will only be reported in the Monday press-release.

Regarding NCDHD COVID Vaccine clinics, we will be **requiring insurance card information** prior to receiving a COVID-19 vaccine. A photocopy of the front and back of insurance cards is needed. **If you do not have insurance, you are still eligible to get your COVID vaccine.** Please call our office with any questions.

If you already have a scheduled appointment time for a clinic on this list, please arrive at that scheduled time. Please note any location updates.
