Legislative Updates & Priorities

- 1. Discussion of advocacy and session priorities from the Nebraska Association of Local Health Directors. Bills relating to public health provided for discussion. Three areas of support for home visitation, dental access/reimbursement, and Board of Health local authority discussed in detail.
 - a. The Board did not provide any concerns on the current bill list. Board feedback on a local position/action not made from discussion.

Director's Report

- 1. Staffing: Amy Latzel is full time as of 1/1 in Environmental programs.
- 2. New funding: ERA2 with the Holt/Boyd Collaborative; Medical redetermination funds for community event and media. Juul settlement not distributed.
- 3. Parking: POD/Trailer: Looking at options to MOU the POD to another entity and moving the trailer to offsite parking with the goal of more off-street parking.
- 4. Main floor remodel update: Deadline 12/31/2024 with funds. Will be a priority as we move into the 2024 calendar year and may require special meetings.
- 5. Community Health Assessment (CHA) bidding: Working on 2025 bidding; partners are seeing a large increase in the bids. Shared cost with partners.
- 6. EMR implementation: Looking for a suitable program. Jennifer Booker is staff member in the lead. A committee is reviewing systems.
- 7. National Association of Local Boards of Health (NALBOH) membership: This membership is primarily for the Board members to utilize if they need or would like to learn more about their Board position and responsibilities. Info sheet provided with more info.
- 8. President's Award Nominations: Award to highlight and individual that has supported public health work across the state. No suggested nominations provided by the board.
