

Who is Eligible

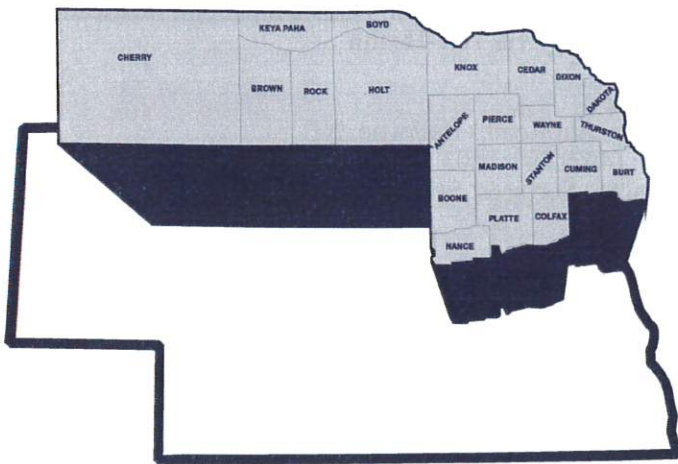
- Individuals must meet financial eligibility criteria.
- Clinical criteria must be met.
- Citizenship/lawful presence as defined by Neb. Rev. Stat 4-108 to 4-114 and living in the state voluntarily with the intent of making Nebraska his/her home.
- For individuals regardless of citizenship/lawful presence status receiving emergency services or inpatient or outpatient treatment mandated by Mental Health Board or for individuals mandated into the care of DHHS by a court order.

How Eligibility is Determined

- Providers determine eligibility by having the consumers complete an eligibility worksheet, and provide at least two months proof of income.
- Clinical criteria is determined via the CDS. (authorized services)
- Citizenship is verified via an attestation form and the SAVE system.

What Region 4 Pay's For...

- Contracted Behavioral Health Services.
- Via LOA (Letter of Agreement) Region 4 can pay for services contracted by another Region (prior Regional approval required).
